

Decree no. 6/2024

of the Rector of the Medical University of Gdańsk dated 23 February 2024

concerning the organisation of the academic year 2024/2025

Pursuant to art. 23 sect. 1 and sect. 2 p. 2 of the *Higher Education and Science Act of Law* dated 20 July 2018 (Journal of Laws 2023, it. 742), par. 23 sect. 1 and sect. 2 p. 2, par. 28 sect. 5 and par. 70 sec. 6 of the *MUG Statute* dated 3 June 2019 (namely, App. No. 1 to the Resolution 69/2023 of the MUG Senate dated 27 November 2023) in accordance with par. 4 of the *Rules of Study* that constitutes App. No. 1 to the Resolution 10/2023 of the MUG Senate dated 27 March 2023 concerning the introduction of the *Rules of Study*

it is now decreed, as follows:

§ 1

At the Medical University of Gdańsk the academic year 2024/2025 starts from 1 October 2024 and lasts to 30 September 2025 according to the following semester division:

Summer retake examination session	from 01.09.2025	to 12.09.2025
Dean's time limit for appeal	from 13.09.2025	to 30.09.2025

Note:

- On the day of the inauguration of the academic year, Rector's hours are planned.
- *Academic classes in the summer semester for Pharmaceutical and cosmetic manufacturing and the 6th year of Medical studies [Polish and English Division] may last till 30 June 2025.
- Orientation Week for 1st year students of English Division lasts from 23 September 2024 to 27 September 2024.
- The terms of the examination session do not apply to students of Pharmaceutical and Cosmetic Industry; Sustainable Drug Discovery, 6th year of Pharmacy, doctoral students, and students studying in the block system, who are subject to a continuous examination session (exams are held immediately after classes in a particular subject).
- During the academic year vocational practice in accordance with the study programme is obligatory.

- During the non-teaching period, summer internship in accordance with the study program is mandatory.
- Vacation dates, holiday break dates do not apply to 6th year Pharmacy students and doctoral students.

§ 2

The following subdivision of the academic year pertains to students who end their studies with diploma examination and defend their thesis:

Winter semester:	from 01.10.2024	to 16.02.2025	
classes during Winter semester	from 01.10.2024	to 16.02.2025	
Summer semester:	from 17.02.2025	to 30.09.2025	
classes during summer semester	from 17.02.2025	to 27.07.2025	

Part-time students have no semester break, or any strictly defined examination session. The examinations are held directly upon completion of the specific course. The retake examination session must end by 12 September 2025.
